

## So Amazing Wedding Give-Away Contest Rules

### Who Can Enter

1. To be eligible to participate in this contest, entrants must be at least 18 years of age and live in the state of North Carolina within the WLFL / WRDC viewing area.
2. Employees of Sinclair Broadcast Group, Inc., Sinclair Television Group, Inc., WLFL, Inc., WRDC, LLC, and any other company which owns, programs or provides other services to television broadcast station WLFL/WRDC (collectively the "Station"), Something Borrowed Something Blue, their affiliated companies, advertising and promotion agencies, any and all local television broadcast and cable stations, local radio and other media companies, and the immediate family members of each are ineligible. - (d) One (1) winning couple will be selected by the staff of Something Borrowed Something Blue from among the valid entries by April 1, 2007.
